<b>GRACE PERIOD:</b>	30 Minutes
	If unable to play the match as scheduled, please contact the opposing team captain prior to the match to make other arrangements. If a team cannot play and no other arrangements can be made, that team will forfeit the match. Both teams would then be responsible for their own kitty money. In the event of a no call, no show, no excuse forfeit, the team that made no attempt to reschedule will receive the forfeit loss AND be responsible for both team's kitty money. Unpaid kitty fees will be deducted from the team's prize check at the end of the season. In the event of a forfeit, please notify the League Dept. in a timely fashion. A team forfeiting 3 weeks during the season or any time during the last 3 weeks of the season may be removed from the league and may also forfeit any prize money.

<b>SANCTION FEE:</b>	\$6.00 per team (SVI) All sanction fees will be deducted from each team's prize check at the end of the season.
