<b>FORMAT:</b>	3 Player - 12 Games (Rack your own break)
<b>START TIME:</b>	7:30 pm
<b>GRACE PERIOD:</b>	30 Minutes
	If unable to play the match as scheduled, please contact the opposing team captain prior to the match to make other arrangements. If a team cannot play and no other arrangements can be made, that team will forfeit the match. Both teams would then be responsible for their own kitty money and the team receiving the forfeit win should still turn in a score sheet indicating a forfeit win. In the event of a no call, no show, no excuse forfeit, the team that made no attempt to reschedule will receive the forfeit loss AND be responsible for both team's kitty money. Unpaid kitty fees will be deducted from the team's prize check at the end of the season. A team forfeiting 3 weeks during the season or during the last 3 weeks of the season may be removed from the league and may also forfeit any prize money.
<b>DAYS OFF:</b>	None
<b>WEEKLY KITTY:</b>	\$5.00 per player per night (Plus price to play games)
<b>SANCTION FEE:</b>	\$9.00 per team for SVI, \$10 per player for ACS, \$10 per player for WSPA. All sanction fees will be deducted from each team's prize check at the end of the season.
<b>SCORESHEETS:</b>	The HOME team is responsible for making sure all kitty money & score sheets are turned into Buck's the same night of play. The white copy is to be sent in with the kitty fee, the yellow copy is for the team's records.
<b>WEATHER:</b>	Stansfield Vending League Dept. will <u>NEVER</u> cancel league due to weather. It is up to each team to contact the team they are scheduled to play to make other arrangements if they feel uncomfortable playing. In some cases, the league president may cancel the entire league and make arrangements for the entire week to be played on a later date.
